### A. MIXED VACCINATED AND UNVACCINATED PEOPLE

#### 1. Indoors: Meeting House, (Sanctuary & Commons)

- a. Capacity: 100 people
- b. Fully-masked
- c. Maintain six feet distance
- d. A family household can sit together
- e. No food or drinks are allowed

#### Indoors: Hollin Hall-Fireplace Room

- a. Capacity: 6 ft. of distance = 19 people
- b. Fully-masked
- c. Maintain six feet distance
- d. A family household can sit together
- e. No food or drinks are allowed

#### Indoors: Hollin Hall-Dining Room

- a. Capacity: 6 ft. of distancing = 12 people
- b. Fully masked
- c. Maintain six feet distance
- d. A family household can sit together
- e. No food or drinks are allowed

#### 2. Outdoors

- a. Capacity: 250 people
- b. Fully-masked
- c. Maintain six feet distance
- d. A family household can sit together
- e. Food or drinks are allowed

#### Bathroom: Can be used in the Meeting House and in Hollin Hall

- a. Remain fully-masked
- b. Maintain 6 feet distance for people waiting outside the bathroom
- c. For large groups, place a line of markers 6 ft apart leading from the door to the bathroom

**The Task Force recommends all groups have a designated person to ensure compliance with these guidelines.**

**B. GROUPS WITH ONLY FULLY VACCINATED PEOPLE**

The CDC does not define small groups nor give a number. The COVID Task Force recommends that small group size be increased to 25 people.

**1. Indoors: Meeting House (Sanctuary & Commons)**

- a. Capacity: 25 people
- b. Masks not required
- c. Social distancing not required
- d. Food and drinks are allowed

**Indoors: Hollin Hall Fireplace Room**

- a. Capacity: 25 people
- b. Masks not required
- c. Social distancing not required
- d. Food and drinks are allowed

**Indoors: Hollin Hall Dining Room**

- a. Capacity: 25 people
- b. Masks not required
- c. Social distancing not required
- d. Food and drinks are allowed

**2. Outdoors**

- a. Capacity: 25 people
- b. Masks not required
- c. Social distancing not required
- d. Food and drinks are allowed

**Fully vaccinated groups do not have to present proof of vaccination.  
We are relying on individuals' honesty about their vaccine status.**

**Bathroom Use for fully vaccinated people: Bathrooms can be used in the Meeting House and in Hollin Hall.**

- a. Masks not required
- b. Social distancing outside the bathroom not required

**C. RENTAL GROUPS**

- 1. MVUC can rent indoor and outdoor space to groups.**
- 2. Rental groups that have mixed vaccinated and unvaccinated people must agree in writing to follow the MVUC Guidelines and the Virginia State Guidelines (see Section A above).**
- 3. Rental groups that include only people who are fully vaccinated must agree in writing to follow the MVUC Guidelines in Section B above.**

**D. June 13<sup>th</sup> Service**

The Task Force recommends the speakers and singers do not need to wear masks since they are fully immunized. A distance of 6 feet needs to be maintained from other congregants.
